



Light The Night 2026 – Terms and Conditions

By purchasing a ticket and/or participating in Light the Night 2026 (“the Event”), organised by St Giles Hospice, Registered Charity Number 509014, you agree to the following Terms and Conditions:

1. Registration & Tickets

1.1 All participants must register in advance and purchase a valid ticket to take part in the Event.

1.2 Early bird tickets are limited in number and available for a restricted time only. Once sold out, standard ticket pricing will apply.

1.3 The exclusive discount code **LTNEARLY** is valid only during the promotional period stated and cannot be used in conjunction with any other offer.

1.4 All ticket purchases are non-refundable and non-transferable unless the Event is cancelled by the organiser (see Section 8).

1.5 Participants must retain proof of purchase and present confirmation if requested.

1.6 Registration fees are not eligible for Gift Aid. Any sponsorship raised must be paid directly to St Giles Hospice and must not be retained by participants.

1.7 The exclusive discount code **EASTERS5** is valid only during the promotional period stated and cannot be used in conjunction with any other offer.

2. Participation

2.1 Participants take part in the 8k walk at their own risk.

2.2 All participants confirm they are medically fit and able to complete the walk. Participants should seek medical advice from a qualified professional if they have any concerns about their ability to take part.

2.3 Participants must be aged between the age of 16 or over on the date of the Event. Participants aged 16 to 18 must be accompanied by a responsible adult aged 18 or over, who accepts full responsibility for them throughout the Event.

2.4 The organiser reserves the right to refuse entry or remove any participant whose behaviour is deemed unsafe, inappropriate, or disruptive.

2.5 Dogs are not permitted at any part of the event.

3. Event Information

3.1 The Event will begin at 6:30pm, with the walk commencing at approximately 9:00pm. All timings are approximate and may be subject to change for operational or safety reasons.

3.2 Participants must follow all instructions provided by event staff, volunteers, stewards, and safety personnel.

3.3 The route may be subject to change due to safety, weather, or unforeseen circumstances.

3.4 The route may include public roads, pavements, grassed areas and uneven terrain. Participants acknowledge that normal public highway risks may apply and agree to always exercise due care and attention.

3.5 The route may not be suitable for wheelchair users or those with limited mobility. Participants are encouraged to contact the organiser in advance to discuss accessibility requirements. While reasonable adjustments will be considered, the organiser cannot guarantee that all sections of the route will be fully accessible.

4. Event T-Shirts & Event Pack

4.1 Each registered participant will receive one official Light the Night T-shirt.

4.2 T-shirts can be collected from the organiser's Whittington site during the designated collection period or on the day of the Event.

4.3 A digital event pack will be issued via email prior to the Event. It is the participant's responsibility to ensure a valid email address is provided at registration.

4.4 T shirt sizes are subject to availability and cannot be guaranteed.

5. Health & Safety

5.1 Participants must wear appropriate clothing and footwear suitable for walking 8k.

5.2 As this is an evening event, participants are encouraged to wear illuminated or reflective accessories for visibility.

5.3 Whilst there will be first aid available at the event, participants are responsible for their own hydration, wellbeing and personal medical needs during the Event.

5.4 The organiser accepts no responsibility for loss, theft, or damage to personal belongings during the Event.

6. Photography & Media

6.1 The Event will be photographed and filmed for promotional and marketing purposes.

6.2 By attending, participants consent to the use of images or footage in which they may appear across digital, print, and social media platforms.

6.3 If a participant does not wish to be photographed, they must notify the organiser in writing prior to the Event.

7. Alcohol & Conduct

7.1 A licensed bar will be available on site. Challenge 25 will be in operation, and valid ID will be required.

7.2 Participants are expected to behave responsibly. The organiser reserves the right to refuse service or entry to anyone under the influence of alcohol or behaving inappropriately.

7.3 The organiser operates at a zero tolerance approach to abusive, discriminatory, harassing or unsafe behaviour. Participants who fail to follow steward instructions or whose conduct poses a risk to themselves, or others may be removed from the Event without refund.

8. Cancellation & Changes

8.1 The organiser reserves the right to amend event details where necessary due to circumstances beyond their control, including but not limited to severe weather, public safety concerns, or government restrictions.

8.2 This also includes, but is not limited to, acts of God, extreme weather conditions, fire, flood, civil unrest, terrorism, public health emergencies, local authority restrictions or any other force majeure event beyond the organiser's reasonable control

8.3 In the event of cancellation by the organiser, participants will be offered either a refund or transfer to a rescheduled date (if applicable).

8.4 The organiser is not liable for any additional costs incurred by participants (e.g., travel or accommodation).

9. Liability

9.1 Participants acknowledge that participation in the Event is voluntary.

9.2 To the fullest extent permitted by law, the organiser shall not be liable for any injury, loss, or damage sustained during the Event, except where caused by negligence.

Nothing in these Terms and Conditions shall limit or exclude liability for death or personal injury resulting from negligence, or any other liability which cannot be excluded by law.

10. Data Protection

10.1 Personal information provided during registration will be used for the administration and delivery of the Event, including event communications, safety management and participant support, in accordance with applicable data protection legislation including the UK General Data Protection Regulation and the Data Protection Act 2018.

10.2 Personal data may be shared with carefully selected third parties who are directly involved in delivering the Event, such as payment processors and medical providers, where necessary for event administration and safety. Such data will not be shared for unrelated marketing purposes.

10.3 Contact details may be used to send important event information and future communications, unless the participant opts out.

10.4 Where consent is provided, participant details may be used for marketing communications about future events and fundraising activities. Participants may withdraw consent at any time.

10.5 All personal data will be processed in line with St Giles Hospice's Privacy Policy available on the hospice website at [Privacy Policy | St Giles Hospice](#), which sets out participants' rights including the right to access, rectify or erase their data.
